## **#GivingTuesday Rules and FAQ's**

**Participation:** Any individual may donate. Donations made through givingtuesday.razoo.com to nonprofit organizations through fundraising pages are 100% tax deductible and irrevocable. Donations will not be refunded. Contributions may only be made via credit or debit card. Checks are not accepted for this online giving event.

**Eligibility for donations and prizes**: All registered charity organizations approved and listed on Razoo are eligible to receive donations and prize grants. Please note that private non-operating foundations cannot receive donations on Razoo.com and are therefore not eligible to participate. Please see <a href="www.razoo.com/terms">www.razoo.com/terms</a> for more information on Eligability.

## Leaderboard eligibility:

#GivingTueday Fundraisers Leaderboard: All charity fundraising or project pages with "#GivingTuesday" in the text of the page prior to November 26, 2013 will be included on the leaderboard.

#GivingTuesday Nonprofits Leaderboard: All charities who have claimed their nonprofit page on Razoo prior to November 26, 2013 are will appear on the Nonprofit Leaderboard.

**[Updated]** While we strongly recommend fundraisers use the tag "#GivingTuesday" in their page, we will include pages that contain variations such as "#Giving Tuesday", "Giving Tuesday", or "GivingTuesday".

**Minimum donation**: The minimum donation on givingtuesday.razoo.com is \$10.00. There is no maximum donation amount. This is a 24 hour giving event, please make your donations during Tuesday, December 3, 2013 to ensure your donation counts towards prizes.

**How can I make a contribution:** Contributions may be made via credit or debit card at givingtuesday.razoo.com.

**How much of the donation will go to the nonprofit:** The nonprofit organization will receive the full donation less the flat rate of 4.9% which covers the credit card processing fees and Razoo fees. There is no fee for your #GivingTuesday fundraiser to participate in #GivingTuesday.

## **FAQs**

What is #GivingTuesday: In the week following Thanksgiving, Americans will spend millions of dollars in the shopping frenzies around Black Friday and Cyber Monday. #GivingTuesday is a day to remind us all that giving means much more than the exchange of material goods—it means volunteering at a local shelter, helping out a friend in need, and, of course, donating to worthy causes.

**Minimum donation**: The minimum donation on givingtuesday.razoo.com is \$10.00. There is no maximum donation for #GivingTuesday. This is a 24 hour giving event, please make your donations during Tuesday, December 3, 2013 Eastern Time to ensure your donation counts towards prizes.

**About Your Donation:** 95.1% of your donation will be disbursed to nonprofits participating in #GivingTuesday. All donations on givingtuesday.razoo.com are made to the Razoo Foundation, a 501(c)(3) tax-exempt organization that permits donors to advise a regranting of their donations to qualified charitable organizations.

What is the Razoo Foundation: It is Razoo Foundation, normal practice to regrant 95.1% of its contribution to the qualifying organization as advised by the donor, retaining 4.9% for Razoo Foundation's expenses (including credit card transaction costs). 100% of your online charitable gift is receipted as a charitable contribution to Razoo Foundation, advised for regrant to your chosen charity.

**Do I need to have an account with Razoo to donate?** No, you do not need to create an account to make a donation. However, if you plan to give multiple times creating an account means you only have to enter your credit card information once. Your account also collects your tax receipts in one location, enables you to track your donation, review the charities you support, and schedule future giving.

Can I make a donation on #GivingTuesday to an organization from my mobile device? Yes. #GivingTuesday mobile facilitates quick, easy and secure donations on all web-enabled mobile devices and is a great tool for donors and nonprofits during Tuesday, December 3, 2013 for giving on the go! Simply visit givingtuesday.razoo.com on any web-enabled mobile device to make a donation or learn about a nonprofit or school.

Who will receive my contact information? The organization(s) or fundraising page you choose to support will receive donor name and contact information, unless the donor chooses to make an anonymous contribution.

**How do I get a tax receipt?** Your tax receipt is e-mailed to you immediately by Razoo Foundation upon successful processing of your donation. To claim a donation as a deduction on your U.S. taxes, please retain your email donation receipt as an official record.
